

CITIC MEMORANDUM - 2024-034

TO THE INVESTING PUBLIC AND THE TRADING PARTICIPANTS

PUBLICATION OF DISCIPLINARY ACTIONS **SUBJECT**

DATE **27 December 2024**

As mandated by Article XII, Section 6 of the Capital Markets Integrity Corporation ("CMIC") Rules, which states in part that CMIC shall publish on its website the sanctions imposed on trading participants ("TPs"), attached is a list of the TPs penalized by CMIC, together with details on the securities laws violated and the corresponding disciplinary actions. The period covered is from 1 May 2024 to 27 December 2024.

It must be emphasized that the list may cover matters recently decided by CMIC, including cases that, after having been resolved by CMIC, are or may be appealed to the Securities and Exchange Commission and/or the courts. Conversely, the list does **not** include matters that are pending resolution by the Board of Directors of the CMIC ("CMIC Board") or where the period to appeal to the CMIC Board has not yet lapsed.¹
